 - Skull Valley Elementary School conducts parent/teacher conferences one each semester. (This year conferences will be held on October 6, 2022 and March 9, 2023.)

- 3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows:
 - Skull Valley Elementary School provides quarterly report cards.
 - Skull Valley Elementary School provides quarterly progress reports for students with IEP's. These reports provide information to parents regarding student progress on individual goals.

 - Due to our small school environment, parents are able to consult with teachers and staff when needed. Teachers and staff are always available through email and phone calls on a daily basis.

 - Parents are encouraged to volunteer and participate in class for specific
 activities, such as the science fair. Parents may call to schedule a time to
 observe in the classroom. Parents are always invited to attend school field trips.
 Specific opportunities for parent involvement also include school plays, the
 school track meet, and end of the year picnic.

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- Monitoring attendance.
- Making sure that homework is completed, including reading for at least 30 minutes each day.
- Monitoring amount of television their children watch.
- Volunteering in my child's classroom or for other school related activities.
- Participating, as appropriate, in decisions relating to my children's education.
- Promoting positive use of my child's extracurricular time.
- Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.
- Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school's School Improvement Team, the Title I Policy Advisory Committee, the District wide Policy Advisory Council, the State's Committee of Practitioners, the School Support Team or other school advisory or policy groups.

Student Responsibilities

We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- Do my homework every day and ask for help when I need to.
- Read at least 30 minutes every day outside of school time.
- Give to my parents or the adult who is responsible for my welfare all notices and information received by me from my school every day.
- Limit the amount of time I spend on the computer, phone, TV and video games.

Additional Required School Responsibilities (requirements that schools must follow, but optional as to being included in the school-parent compact)

The Skull Valley Elementary School will:

- 1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
